Singapore strengthens Personal Data Protection efforts globally

Signs MOU with Mexico and renews MOU with Australia

SINGAPORE, 1 December 2023 — Singapore's Personal Data Protection Commission (PDPC) and Mexico's National Institute for Transparency, Access to Information and Personal Data Protection (INAI) signed a new Memorandum of Understanding (MOU) to strengthen cooperation on personal data protection between both countries, virtually on 1st December 2023, the first such collaboration between Singapore's PDPC and a data protection authority of a Latin American country. Singapore's PDPC and Australia's Office of the Australian Information Commissioner (OAIC) renewed the MOU to deepen collaborations on personal data protection at the 60th Asia Pacific Privacy Authorities (APPA) Forum held in Sydney, Australia, on 1st December 2023.

- 2 Data governance and cross border data flows are essential for global trade in a digital economy. As such, personal data protection is a global issue requiring collaboration between countries to engender trust and facilitate trusted cross border data flows. As part of Singapore's efforts to strengthen personal data protection, Commissioner of PDPC Mr Lew Chuen Hong signed a new MOU with Commissioner Josefina Román Vergara on behalf of the Board of INAI Mexico.
- 3 The scope of collaboration with Mexico's INAI includes the development of compatible data transfer mechanisms to facilitate trusted cross border data flows and cooperation in facilitating technological innovation to enable these trusted data flows. PDPC and INAI will also exchange information, share best practices, and collaborate for research on emerging privacy and data protection issues and trends.

"The collaboration between our countries marks a significant step towards a future where we will work hand in hand to navigate the complexities of the digital age. By focusing on the development of compatible data transfer mechanisms, technological innovation, and information exchange, through



this MOU we are not only shaping our digital futures, but also setting a standard for global cooperation", said Commissioner of Mexico's INAI, Mrs Josefina Román Vergara.

"Singapore's PDPC is committed to facilitating responsible cross border data flows, and the MOU with Mexico's INAI is a significant step forward to bridging the fragmented global landscape for personal data protection. We look forward very much to working closely with Mexico on this.", said Commissioner of Singapore's PDPC, Mr Lew Chuen Hong.
